On behalf of the Illinois Commission on Equity and Inclusion (CEI), and per 30 ILCS 575/8f, I am pleased to present the Fiscal Year 2023 Annual Expenditure Report for the Business Enterprise Program for Minorities, Women, and Persons with Disabilities (BEP).

CEI continues focusing on strategic prioritization to meet its statutory objectives and support its BEP goals and objectives. CEI's mission is to maximize supplier diversity, equity, and inclusion by ensuring access to contracting opportunities by developing procedures and initiatives that make the procurement process inclusive, fair, and equitable while providing support, education, and mentorship. CEI's vision is to be a trailblazing leader in fostering a diverse, equitable, and inclusive procurement environment where supplier diversity, equity, and inclusion are celebrated, and opportunities are accessible to all, driving positive social impact and economic growth.

CEI is dedicated to transformational community progress and fulfilling its statutory responsibilities while fostering collaboration with various internal and external stakeholders. This includes engagements with the four chief procurement officers, all state purchasing officers, and approximately 108 agencies, boards, commissions, and public institutions of higher education to align strategies and initiatives with the broader statewide supplier diversity goals. In FY23, CEI's external stakeholders encompassed a record-breaking 5,415 BEP-certified vendors, non-certified businesses across the State eligible for BEP certification, various industry organizations, numerous prime vendors, and legislators. This extensive network of stakeholders is a crucial part of CEI's collaborative efforts to promote diversity, equity, and inclusion in Illinois' procurement landscape.

This report highlights progress and identifies the FY23 BEP achievement of State agencies and public institutions of higher education subject to the Business Enterprise for Minorities, Women, and Persons with Disabilities Act. The State of Illinois spent \$1,298,743,727 in eligible contract dollars with BEP-certified vendors and sheltered workshops during FY23.

While we value the growth seen in FY23, we are committed to building upon the last fiscal year's successes while addressing areas for improvement. We will continue leveraging data-driven insights and stakeholder feedback to refine BEP strategies and processes, focusing on enhancing supplier diversity, equity, and inclusion across all facets of the procurement process. Through ongoing collaboration and a shared commitment to our mission, we are confident that we can create meaningful and lasting change that benefits all stakeholders involved in Illinois' procurement landscape.

BEP Annual Expenditure Report Fiscal Year 2023

Executive Summary

The Commission on Equity and Inclusion (CEI) submits this Business Enterprise Program (BEP) Annual Expenditure Report on behalf of the Business Enterprise Council for Minorities, Women, and Persons with Disabilities (BEP Council) to Governor Pritzker and the General Assembly. This report outlines the qualified State dollars spent subject to the BEP aspirational goal, provides a review of CEI's FY23 programmatic accomplishments, illustrates the performance of the State agencies and public institutions of higher education subject to the Business Enterprise for Minorities, Women, and Persons with Disabilities Act (BEP Act) during FY23, and includes an analysis of the number of BEP-certified vendors.

The data in this report was submitted to CEI by the purchasing entities subject to the BEP Act in their FY23 Annual BEP Expenditure Reports and FY23 BEP Compliance Plans.

BEP continues to support, promote, and encourage the economic development of minorities, women, and persons with disabilities participating in State procurement as prime vendors and subcontractors. Through engagement and collaboration with other partnering organizations and stakeholders, BEP expands its impact by increasing participation in State contracting opportunities.

Fiscal Year 2023 Metric Highlights

The number of BEP-certified vendors participating in the State's procurement process continues to increase. Over the past five years, vendor participation has had an average yearly increase of 10.5%. The number of certified BEP vendors grew from 3,315 in FY22 to 5,415 in FY23, an increase of 63%. The rise in certification is primarily attributed to more vendors becoming actively certified in BEP through reciprocal certification opportunities and effective outreach engagement.

There was also growth in the dollars subject to BEP goals (DSG). In FY23, \$23.59 billion was subject to BEP goals, a 67% increase from the FY22 DSG amount of \$14.13 billion. This significant year-over-year increase in DSG can be accredited to improved agency and public institutions of higher education reporting compliance.

In FY23, the State of Illinois spent \$1.29 billion with BEP-certified vendors and sheltered workshops, representing a \$142.1 million, or 12.3%, increase over the previous fiscal year. This spending increase is mainly due to the rise in DSG and the influx of certified vendors.

During FY23, 1,538 BEP-certified vendors received State contracts compared to the 1,489 in FY22, which means that the number of certified vendors awarded contracts increased by 3.29%. The increase in contracts awarded to BEP-certified vendors can be attributed to the certified vendor pool growth.

In FY23, the BEP goal achievement for the State of Illinois showed a slight decrease from the previous year, with a reported rate of 5.5%, compared to 8.2% in FY22. While this may initially seem like a decline, it's essential to contextualize this change within the broader landscape of procurement and economic conditions. The decrease in goal achievement can be attributed to several factors, including the substantial rise in DSG, shifts in procurement spending patterns, fluctuations in contracting opportunities, changes in spending patterns, purchasing entity class exemption requests, and evolving market dynamics. Despite this slight decrease, it's crucial to acknowledge CEI's continued dedication to supporting and promoting BEP-certified vendors. CEI's ongoing efforts to enhance supplier

diversity and strategic outreach and capacity-building initiatives have laid a strong foundation for future progress. Furthermore, this change presented an opportunity for reflection and recalibration, allowing CEI to develop an FY24 Strategic Plan and Impact Report to identify areas for improvement and implement targeted strategies to advance programmatic goals further. It is also worth noting that the FY23 BEP goal achievement still signifies a substantial investment in businesses owned by minorities, women, and persons with disabilities, totaling over \$1.29 billion.

Fiscal Year 2023 Programmatic Accomplishments

BEP continued to set programmatic records during FY23. The start of FY23 saw BEP's full implementation of Public Act 102-0585. This public act permits the recognition and acceptance of businesses certified by the City of Chicago, Cook County, or other entities approved by the BEP Council. The Be Enrolled in BEP certification program was created to administer the new certifications from the City of Chicago and Cook County. Later, the program expanded to allow vendors certified through the Illinois Unified Certification Program (IL UCP) to become automatically enrolled as BEP vendors. Members of the IL UCP include the Chicago Transit Authority, METRA Rail, PACE, and the Illinois Department of Transportation.

CEI's first independent competitive request for proposals was published, resulting in a contract with a BEP-certified vendor for a new diversity certification and compliance management system. This system will drive the modernization of BEP's processes, protocols, and forms in alignment with industry best practices while eliminating BEP's former reliance on legacy Excel spreadsheets for data collection and analysis. This improvement will also enhance the ability to track records and improve data integrity.

Additional FY23 programmatic accomplishments include administering monthly BEP Council public meetings and trainings and implementing a comprehensive communication framework. This framework includes regular stakeholder meetings that provide updates on BEP Council decisions, procurement policies, diverse vendor certification procedures, and purchasing entity compliance requirements. Additionally, BEP enhanced its internal systems for stakeholder inquiries and procurement notifications, trained staff to improve communication and response capabilities, and analyzed purchasing entities' supplier diversity efforts to enhance BEP-certified vendors' capacity, revenue growth, and credentials.

CEI remains steadfast in its commitment to fostering an inclusive, equitable procurement environment that reflects the diverse communities it serves, ensuring that every dollar spent contributes to positive social impact and economic growth for all stakeholders.

Fiscal Year 2023 Operational Accomplishments

Compliance

CEI's BEP Compliance Unit ensures compliance in the State's procurement process regarding various aspects of diversity contracting. It oversees the contract goal-setting process, Utilization Plan (U-Plan) reviews, monitoring of BEP-certified prime and subcontractor utilization, and provides required reporting and assistance to all agencies and public institutions of higher education.

The BEP Compliance Unit has made significant progress in ensuring equitable and inclusive procurement practices across State agencies and public institutions of higher education. In FY23, the BEP Compliance Unit received 103

timely compliance plan submissions, indicating a growing commitment from agencies and public institutions of higher education to meet diversity goals. Additionally, 318 U-Plan responsiveness reviews were conducted, with 246 U-Plans meeting the responsiveness criteria, demonstrating the dedication of agencies and public institutions of higher education to comply with BEP requirements. The compliance unit conducted 573 goal-setting form reviews in FY23. These reviews facilitate goal-setting and adherence and foster accountability in achieving supplier diversity objectives. Moreover, the BEP Compliance Unit received 104 annual reports, providing valuable insights into the progress of contracts with BEP prime and subcontractor goals.

As part of its oversight role in FY23, the BEP Compliance Unit also actively monitored the contract goal commitments of purchasing entities, ensuring transparency and adherence to diversity commitments. The team provided vendors with responsive assistance, guidance, and clarity on BEP compliance matters. The BEP Compliance Unit consistently ran reports to maintain data accuracy and up-to-date insights, which enabled informed decision-making and progress evaluations.

Additionally, the BEP Compliance Unit attended pre-bid conferences as needed, addressing concerns and challenges confronted by BEP vendors and purchasing entity partners.

Certification

The BEP Certification Unit demonstrates the State's continued commitment to opportunity and inclusion of minority-owned, women-owned, and persons with disabilities-owned businesses by offering certification opportunities to qualifying vendors.

During FY23, the BEP Certification Unit successfully added 2,100 vendors to the BEP certification vendor pool, bringing the total number of active BEP-certified vendors to 5,415. This growth in the vendor base can be credited to the program staff's diligent participation in targeted outreach efforts, virtual office hours, and informational webinars directed at prospective vendors throughout Illinois. The enhancement in vendor certification numbers can also be linked to the enactment of Public Act 102-0585 in June 2022. This legislation facilitated the recognition of businesses certified as minority-owned or women-owned by the City of Chicago and Cook County within the State of Illinois BEP program. The BEP Certification Unit devised a more efficient registration process to accommodate this integration, enabling already certified vendors from the City of Chicago and Cook County to obtain BEP certification easily. This initiative significantly broadens the pool of vendors eligible to compete in State procurement contracts. In line with ensuring excellent service, the BEP Certification Unit staff also conducted weekly virtual office hours, offering vendors an accessible platform to seek guidance and clarity on the certification process.

The BEP Certification Unit's proactive approach to promptly and helpfully assisting vendors has contributed to streamlining the certification journey, fostering an environment that encourages and supports the growth of diverse enterprises within the State.

Outreach

CEI's Outreach Unit enhances BEP by proactively engaging with diverse businesses. The team fosters awareness and participation in BEP through targeted outreach initiatives, ensuring a robust and inclusive supplier base. By cultivating meaningful connections, providing resources, and offering support, the CEI Outreach Unit drives more excellent representation and economic opportunity for minority-owned, women-owned, and persons with disabilities-owned businesses in the State's procurement ecosystem.

CEI's Outreach Unit made several strides in furthering its impact and operations during FY23. The unit standardized its procedures for processing outreach participation requests. In addition, the Outreach Unit increased CEI's social media presence by cross-promotion and collaboration with fellow State agencies and stakeholders. During FY23, CEI participated in 71 outreach efforts, including pre-bid conferences and quarterly agency procurement officer meetings to support supplier diversity comprehension and execution.

Mentor Protégé Program

The Mentor Protégé Program (MPP) fosters the development and mentoring of minority, women, and persons with disabilities-owned businesses. It will enable experienced firms to provide various types of support to create more equitable access for economic growth while meeting the State's BEP contracting goals. The MPP's goals are to motivate and encourage established businesses to provide developmental assistance to BEP-certified firms, to maximize access to the State's procurement programs, to foster long-term relationships, to enhance the core capabilities of minority-owned, women-owned, and persons with disabilities-owned businesses, and to increase contracting opportunities for those businesses.

In FY23, the MPP staff continued collaborating with internal and external stakeholders to identify interested participants. MPP staff also worked to strategically align the MPP with the BEP Compliance Unit to formulate a potential approach for the MPP's future involvement in State contract bids. Throughout FY23, the MPP staff continued their programmatic buildout and established essential foundational aspects necessary for the program's operation.

CEI has outlined several strategic actions to advance the MPP and strengthen its impact. First, filling staff vacancies is a priority to ensure the program is adequately resourced and supported. CEI will conduct targeted outreach and awareness campaigns to expand the program's reach and engagement, leveraging channels such as industry events and social media platforms to connect with BEP vendors and promote mentorship opportunities. CEI will develop a structured approach to optimize the mentor-protégé matching process, considering the unique needs and aspirations of protégé businesses. This personalized matching process will foster productive relationships with experienced mentors who can provide valuable guidance and support. CEI will establish a feedback mechanism to continuously improve the program's effectiveness and gather insights from mentors and protégés. CEI will also conduct regular evaluations to assess the success of mentor-protégé relationships and identify areas for enhancement, ensuring the program remains responsive and impactful.

By pursuing these strategic steps, the MPP will further nurture the growth and development of diverse businesses, fostering mutually beneficial partnerships that promote economic empowerment and increased competitiveness within the State's procurement landscape.

Sheltered Markets

Sheltered Markets are a procurement procedure in which certain State contracts are selected and specifically set aside for businesses owned and controlled by minorities, women, and persons with disabilities through competitive solicitations. Sheltered markets are established by the BEP Council when it finds a pattern of racial, gender, or disability-based discrimination in a particular industry. When establishing a new sheltered market or adjusting an existing one, the BEP Council identifies the evidence used to make a determination and the market segment that falls under the sheltered market.

The two sheltered markets currently available are IT/telecom and advertising. The sheltered market for advertising is only for certified African-American-owned and Hispanic-owned business enterprises.

While the BEP Council didn't establish any sheltered markets in FY23, the Department of Innovation and Technology awarded the Technology Operations Professional Services (TOPS) procurement under the IT/telecom sheltered market.

BEP Council

The BEP Council was developed to help implement, monitor, and enforce the goals of the BEP Act.

In FY23, the BEP Council actively participated in several key initiatives to enhance diversity and inclusion within State contracting. Through the diligent efforts of the BEP staff, the BEP Council has established a streamlined registration procedure to recognize certified businesses owned by minorities, women, or persons with disabilities, working with approved entities like the City of Chicago and Cook County. Additionally, through the BEP Compliance Unit, the BEP Council has diligently granted individual contract exemptions from State contracting goals and waivers to contractors who demonstrate genuine efforts to meet participation goals. In FY23, the BEP Council Compliance Subcommittee also reviewed and made determinations on purchasing entity class exemption requests. The BEP Council members' commitment to monthly meetings underscores their dedication to fulfilling their responsibilities under the BEP Act. Moreover, the BEP Council's efforts extend to maintaining an up-to-date and comprehensive list of businesses legitimately classified as diverse enterprises through the BEP staff. Their crucial role also includes reviewing compliance plans submitted by State agencies and public institutions of higher education and certification appeals submitted by vendors, ensuring a holistic approach to promoting diversity and equity in State procurement practices.

Moving forward, the BEP Council is committed to fulfilling its statutory obligations. The BEP Council will strengthen and optimize the program's impact by identifying areas for improvement and proposing necessary changes to enhance its effectiveness.

Fiscal Year 2024 Impact Report

In FY24, CEI secured new office spaces in Chicago and Springfield dedicated to BEP operations and facilitating accessibility and efficiency in BEP services. Additionally, CEI proposed updated bylaws to the BEP Council and administered monthly public meetings to foster transparency and collaboration. CEI implemented an internal tracking system to ensure timely responses to stakeholder inquiries, reinforcing the commitment to stakeholder engagement. Furthermore, CEI's comprehensive analysis of current laws and policies led to drafting proposed legislation aligned with BEP objectives. Moreover, CEI's FY24 collaboration with legal experts and legislative sponsors culminated in the submission and filing of CEI's first legislative proposals. CEI also prioritized capacity-building initiatives, including the development of standardized BEP certification and compliance processes and training programs, exemplifying CEI's dedication to continuous improvement and excellence in service delivery. Furthermore, CEI launched its online training academy, offering State personnel a dynamic platform to enhance their knowledge and understanding of essential supplier diversity procurement concepts. CEI also revised BEP reporting templates and maintained comprehensive lists of BEP-certified businesses. Furthermore, CEI collaborated with legal experts to update the BEP administrative rules and finalized its organizational chart restructuring.

BEP is projected to complete 84 outreach efforts in FY24. In March of 2024, the BEP Certification Unit will begin conducting new monthly virtual educational webinars to assist business owners with the BEP certification application process and help BEP vendors know the next steps after achieving BEP certification.

Through these accomplishments, CEI remains steadfast in its mission to promote diversity, equity, and inclusion, driving positive change and fostering a more inclusive procurement environment for all stakeholders.

Fiscal Year 2025 Target Growth Initiatives

This list of target growth initiatives outlines the specific objectives and initiatives to drive growth and progress within CEI. CEI carefully designed these initiatives to expand the reach and impact of CEI's mission, focusing on increasing supplier diversity and fostering economic development among diverse businesses. By setting clear growth targets and strategic priorities, CEI aims to create a more inclusive and equitable procurement landscape, thereby contributing to advancing diversity and economic opportunities across Illinois. Through the following initiatives, CEI endeavors to strengthen its role as a catalyst for positive change and a driver of meaningful progress in supplier diversity:

- Continued monitoring of contract BEP goal commitments.
- Increased awareness of CEI's supplier and workplace diversity functions with purchasing agencies, public institutions of higher education ("PIHEs"), vendors, and other external stakeholders.
- Increased accuracy and efficiency of CEI's supplier diversity tracking and reporting processes.
- Standardized supplier diversity processes and procedures.
- Increased purchasing entity direct and indirect spending with BEP-certified vendors seeking procurement and contract opportunities.
- Diverse business outreach initiatives that connect, inform, and increase engagement.
