EXECUTIVE SUMMARY

Introduction

Governor Bruce Rauner is committed to promoting the growth and prosperity of small and diverse businesses within the State of Illinois. The Department of Central Management Services' (CMS) Business Enterprise Program (BEP), is committed to achieving Governor Rauner's vision by ensuring access and opportunity for entrepreneurs through targeted procurement initiatives. BEP promotes the growth of small businesses owned by minorities, females and persons with disabilities to the maximum extent possible.

BEP oversees and reviews all procurement contracts over \$250,000 for appropriate BEP goal inclusion and contract compliance monitoring. The Fiscal Year 2015 Annual Report provides an overview of the dollars spent by agencies and universities with BEP certified vendors participating in state contracts. This report outlines the total amount subject to the BEP goal; a breakdown of BEP goal achievements attained by 63 State agencies and universities; and illustrates achievement levels by statutory demographic categories.

During FY15, CMS set out to enhance its BEP efforts. A statewide diversity inclusion forum was hosted with Agency Officials, Chief Procurement Officers and BEP Liaisons. Governor Rauner opened the meeting and reinforced his commitment to the small minority, female and persons with disability owned business community. Guidance and program support was provided to all attendees. In addition, BEP has focused its outreach efforts to educate diverse small businesses on State purchasing opportunities and certification requirements. These initiatives have helped solidify more responsive bids with respect to the State's purchasing procedures, and have achieved increases in BEP participation at varying industry levels.

Historical Background

The Business Enterprise Program was created in 1984 pursuant to the Business Enterprise for Minorities, Females and Persons with Disabilities Act (Act) (30 ILCS 575/1 et.seq.), defining the policy of the State of Illinois to promote and encourage the continuing growth of businesses owned by minority; females; and persons with disabilities. This Act is applicable to all agencies and universities under the jurisdiction

of the Office of the Governor. The Act originally established a statutory statewide BEP participation goal of 10%. In 2010, this goal was raised to 20%. The Act also calls for the creation of the Business Enterprise Council consisting of 19 appointed members including representatives of the business community and State agencies. The BEP Council helps implement, monitor and enforce the policies and goals of the Program.

Fiscal and Legislative Accomplishments

All State agencies and universities have made a concentrated effort to ensure BEP vendors participate in the procurement process involving all industry groups. This effort has resulted in \$557,931,503 spent with BEP eligible companies, representing a 34.2% participation achievement of all contract dollars that were subject to the BEP goal. This FY15 participation represents a 31% increase from FY14 contract dollars spent with BEP firms. The FY15 increase is a result of added BEP companies participating in Capital Development Board (CDB) grants and Health & Family Services (HFS), healthcare administration contracts.

During FY15, BEP certified **1,799** individual firms which established the State's BEP vendor base. This FY15 BEP certification achievement represents a **5%** increase from FY14 levels. CMS targeted outreach efforts contributed to this vendor increase which recruited added professional service and construction firms to the overall BEP vendor base. Further, **892** individual BEP companies received a total of **5,478** contracts, with an average contract amount of **\$90,455**.

Pursuant to Public Act 97-260, BEP staff are also responsible for the oversight and administration of the Service Disabled/Veterans Small Business Program. This program provides for participation opportunities by Veteran and Service Disabled Veteran-owned small businesses to compete for State procurement opportunities. Program oversight operates in conjunction with the ongoing BEP duties and responsibilities. A separate report is issued outlining the success of this Program.

FY15 also resulted in the completion of the State of Illinois Disparity Study conducted by Colette Holt and Associates. The study provides a foundation for the continuation of the Business Enterprise Program. The study's results were presented to the Governor's office and General Assembly on December 31, 2015. CMS is currently reviewing ways in which to implement a number of recommendations outlined in the Study. The study may be found on the Department's website.

Certification Accomplishments

The Business Enterprise Program took steps to reduce undue burden on the firms currently certified in the Program. BEP increased certification periods from three to five years, allowing participants longer eligibility periods and eliminated unnecessary paperwork. This certification term increase now allows firms to focus their attention on competing for business opposed to certification requirements. FY15 outreach efforts have yielded the largest BEP certified vendor base in the State of Illinois within the past 5 years.

Outreach Efforts

CMS has joined forces with Federal and State agencies such as the Small Business Administration (SBA), the Illinois Procurement Technical Assistant Centers (PTAC), Small Business Development Centers (SBDC), and local Chambers of Commerce, as well as other assist agencies and community based organizations across Illinois to create better business resources. This combined effort has increased our ability to provide comprehensive business tools to BEP companies helping them to succeed in competing for procurements within the mainstream of their respective industries.

Program staff is available to assist current and prospective vendors addressing all aspects of doing business with State agencies and universities. During FY15, CMS sponsored or participated in 61 outreach events and workshops across the state. In addition to providing training to BEP entrepreneurs on the certification process and in navigating the State's procurement process, prime and subcontractors also receive critical guidance on contract compliance requirements. Both efforts help to ensure responsiveness and BEP accountability in solicitations for the State procurements. BEP also maintains an open door policy in providing one-on-one consultations.

Contract Compliance

CMS has established consistency in agency and university reporting to ensure transparency in BEP achievements, Utilization Plans, Decision Memorandums, Goal Setting procedures, and training for agencies to elevate BEP goal setting accountability. Added Contract Compliance monitoring tracking modules are being researched and business processes are under review that will work compatibly with certification modules and statewide procurement computer programs.

Additionally, during FY 2015 BEP staff participated in all pre-bid conferences to present BEP requirements for solicitations which contained BEP goal requirements.

Outlook for Fiscal Year 2016

CMS will continue to expand its efforts in areas of certification, compliance and outreach with stakeholders, with the goal of increasing the number of diverse businesses across Illinois. To that end, BEP will be adding new assist agency partners across Illinois to help promote BEP *Recognition Certification with small businesses owned by minorities, women and persons with disabilities.* Recognition applicants are businesses that are currently certified as minority/female owned businesses with other entities and may be eligible to participate in the BEP with expedited processing.

CMS will also be updating existing mainframe/software programs to provide timely reporting and tracking for all certification and contract compliance needs. We will also be announcing, industry specific Diverse Business Symposiums in 2016, to enhance overall outreach and training activities.

BEP will continue to strive to improve the economic success of all diverse businesses by identifying opportunities and access to State procurement information. Increasing the ability of businesses owned by minorities, females and persons with disabilities to remain competitive within the mainstream of their respective industries, helps their growth and development and the overall success of the Program.


