EXECUTIVE SUMMARY

Introduction

With the strong support of Governor Bruce Rauner, the Business Enterprise Program (BEP) is continuing to support, grow, and build minority, women and persons with disabilities owned firms doing business with the State of Illinois. Through different initiatives, including the Sheltered Markets Executive Order, E.O. 2016-08, Governor Rauner continues to increase access and opportunities for entrepreneurs through the Business Enterprise Program despite an ongoing budget impasse.

This report, submitted by the Business Enterprise Council for the Minorities, Females, and persons with Disabilities, outlines the qualified State dollars spent subject to the BEP goal and illustrates the State's strong commitment to do business with firms within the different communities.

On the 30th anniversary of this Program's report, BEP is pleased to report the second highest BEP vendor spend in State history. BEP continues to assist and empower gender and ethnic specific entrepreneurs in our state.

Historical Background

BEP was created in 1984 pursuant to the Business Enterprise for Minorities, Females, and Persons with Disabilities Act (30 ILCS 575/1), and began providing this report to the General Assembly and Governor in 1986. Though much has been accomplished in the last 30 years, there is much more work to be done.

Legal Accomplishments

BEP is thrilled to assist in implementing Governor Bruce Rauner's Executive Order 2016-08 regarding Sheltered Markets. The Governor, through the disparity study of 2015, outlined 6 areas of improvement. Those areas are: Mentor/Protégé Program, electronic contracting, financial assistance, goal setting, procurement forecasting, increased information, and removal of barriers. Pursuant to the executive order, the first sheltered market Request for Proposal (RFP) was sent to the public in the area of Information Technology.

Certification Accomplishments

On August 9, 2016, BEP launched the Opportunities. Illinois.gov system to remove red tape for prospective BEP vendors. This fully paperless and online system provides a real-time status update to both the prospective vendor and the BEP certification analyst throughout the certification process. This software program gives the prospective vendor control over the certification process. It also offers prime vendors an easy way to search and communicate with BEP vendors.

Opportunities. Illinois.gov has given BEP an opportunity to effectively reduce the time for which it takes BEP to reach a certification decision. During FY 2016, BEP was in 98% compliance of making a decision within the allotted 60 day statutory requirement for certification.

The BEP certification team is looking forward to being able to certify all qualified vendors in the future with the new system in place.

Outreach Efforts

In FY 2016, BEP Outreach began the long-term strategic plan for hosting various prime and subprime vendor events and quarterly industry specific events. Partnering with different state agencies and prime vendors, these events have and will give BEP vendors the tools they need to thrive in the State of Illinois.

Outreach continues to be a valued asset to our ongoing certification improvement process. With the new system of Opportunities. Illinois.gov, outreach can lead vendors through the certification process via phone more efficiently.

Considering the limited resources available, BEP outreach has traveled the state to 61 events, hosted/co-hosted 3 events, and participated in shows/expos, panels, and networking events. BEP outreach is looking forward to strengthening its outreach efforts and expand its presence throughout the State of Illinois in Fiscal year 2017.

Outlook for Fiscal Year 2017

The Business Enterprise Program Council is looking forward to a strong, positive, productive fiscal year 2017.

As previously stated, Outreach is developing a long term strategic plan of events that BEP will host/co-host on a monthly basis in an effort to increase certified BEP vendors and expand the vendor pool to allow BEP to potentially increase BEP spend dollars.

In accordance with Executive Order 2016-08, BEP and CMS look forward to executing the directives of Governor Bruce Rauner. BEP will focus on removing barriers for BEP vendors and on a strong compliance system to ensure the integrity of CMS, BEP, and those we serve.

With ample opportunity to grow, the Business Enterprise Council is enthusiastic for the positive changes that are yet to come with BEP, CMS, and the people of the great State of Illinois.


