On behalf of the Illinois Department of Central Management Services (CMS) and the Business Enterprise Council, I am pleased to provide you with the Fiscal Year 2019 Annual Report for the Business Enterprise Program for Female, Minorities, and Persons with Disabilities (BEP).

This report details the achievements and reforms of the Business Enterprise Program during Fiscal Year 2019, as well as the performance of State agencies and institutions of higher education that are subject to the BEP Act (30 ILCS 575).

During Fiscal Year 2019, the State of Illinois spent \$649,423,044 in eligible contract dollars with BEP-certified businesses. This is the highest recorded contracting total going to BEP-certified businesses since the program's inception. Fiscal Year 2019 also witnessed a record number of more than one thousand BEP vendors actively engaged in the BEP-qualified State procurements. The total represents more than half of all the BEP-certified vendors for the year.

We are proud of this achievement, but we realize there is still much work to be done to further expand participation in BEP. CMS continues its commitment to increase contracts awarded to BEP vendors during Fiscal Year 2020 and beyond, and to further reduce existing disparities in State contracting opportunities.

CMS looks forward to working with other agencies, stakeholders, and partners to implement strategic goals detailed in this report. Together, we can continue to support businesses owned by minorities, females, and persons with disabilities, as we ensure that these businesses are afforded fair and equitable opportunities to do business with the State of Illinois, now and in the future.

BEP Annual Expenditure Report FY2019 Executive Summary

This report is submitted by the Department of Central Management Services (CMS) Business Enterprise Program for Minorities, Females, and Persons with Disabilities (BEP), and outlines the qualified State dollars spent with BEP certified vendors.

Created in 1984 pursuant to the Business Enterprise for Minorities, Females, and Persons with Disabilities Program Act (30 ILCS 5757), the BEP continues its efforts to increase procurement access and opportunities for disadvantaged entrepreneurs. Through engagement and collaboration with State agencies and institutions of higher education, the BEP vendor community, and other stakeholders, the State of Illinois seeks to expand the Program's impact through increased participation in State contracting opportunities.

Fiscal and Program/Legislative Accomplishments

In Fiscal Year 2018, the State delivered record results with spending totaling \$607,504,306 going to certified Business Enterprise Program vendors, a total that represents a 23-percent increase compared to the spend in Fiscal Year 2017.

Fiscal Year 2019 spending with certified BEP vendors totaled \$649,423,044 the highest BEP spending level since the inception of the Program. The 2019 spend also represents the largest number of BEP certified vendors involved in State contracts, with a total of 1,021 BEP vendors participating in the State's procurement process for Fiscal Year 2019.

CMS has revised several important policies, procedures, and procurement documentation protocols to further streamline the contracting and review process. Changes for Fiscal Year 2020 include a fully revised Utilization Plan and Letters of Participation, offering more protection within the process. A new Dispute Resolution process will afford BEP-certified vendors a clear policy and procedure to help settle the identified dispute. The Bureau of Strategic Sourcing and BEP will issue a "Buying Guide" that will forecast State contracting opportunities to help vendors plan and prepare for a bid.

With an expanded focus on moving forward and change, CMS also is proposing supportive legislation for the Program and new clarifying language through the Joint Committee on Administrative Rules (JCAR).

New administrative rules to govern the process of identifying and declaring Sheltered Markets were approved and adopted by JCAR. These new rules provide greater clarity for the BEP Council in choosing how and when to declare a Sheltered Market.

Operational Accomplishments

To support the mandates of Executive Order 2018-07, the BEP Compliance Division effectively managed the increase in goal-setting submissions, provided additional training and guidance to State procurement professionals participating in additional pre-bid conferences, and launched a new Compliance Monitoring System.

Compliance

The Compliance Division has implemented a limited version of its Diversity Contract Monitoring System (DCMS) and anticipates a fully automated operational version before the close of Fiscal Year 2020. This system will automatically update with newly issued contracts containing BEP goals. It will allow for more effective monitoring of payments from the Illinois Office of the Comptroller to prime vendors, and from prime vendors to BEP-certified sub-contractors.

Outreach

The BEP Outreach Division continues its partnership with the Department of Commerce and Economic Opportunity (DCEO) through improved outreach efforts to educate diverse small businesses throughout the State about opportunities available within the Program. BEP participates in conferences, conventions, expos, and chamber meetings statewide, throughout the year.

Certification

The Certification Division continues to improve the application process by reducing the review time on all applications within 60 days and streamlining the application by removing redundancies and simplifying questions to further improve staff processing time.

Improvements on the Certification Portal included an external link to the Procurement Process and the Procurement Bulletin to better assist the vendor community.

Mentor Protégé Program

Lastly, the BEP expects to bring a new Mentor Protégé Program Coordinator on board to launch the Mentor Protégé Program by the 3rd quarter of Fiscal Year 2020. The Mentor Protégé Program encourages relationship building and professional development that will benefit both prime contractors and BEP-certified sub-contractors by increasing BEP-certified vendors' capacity to perform on contracts. It will also increase opportunities for those sub-contractors to serve as prime contractors themselves or to partner effectively with larger prime contractors.

Outlook for Fiscal Year 2020

The Business Enterprise Program is poised for another successful fiscal year in 2020, with an improved focus on vendor engagement, process improvement, compliance optimization, and increased procurement opportunities.
