State agencies and public institutions of higher education are obligated to maximize the use of these businesses to the extent possible while maintaining financial and fiduciary responsibility. Additionally, they must actively work to eliminate any obstacles that hinder the full participation of such businesses in procurement and contracting opportunities.

This report identifies the FY23 service category achievement of State agencies and public institutions of higher education and highlights the State's progress toward increasing the use of service firms owned by minorities, women, and persons with disabilities.

Executive Summary

The Commission on Equity and Inclusion (CEI) submits this FY23 Service Category Report on behalf of the Business Enterprise Council for Minorities, Women, and Persons with Disabilities (BEP Council) to Governor Pritzker, the General Assembly, and the Bureau on Apprenticeship Programs and Clean Energy Jobs. This report identifies the service firms utilized by each State agency and public institution of higher education, outlines the efforts made to enhance the utilization of service firms owned by minorities, women, and persons with disabilities, and presents any recommendations provided by the BEP Council to encourage greater involvement of such service firms by State agencies and public institutions of higher education.

The data in this report was submitted to CEI by the purchasing entities subject to the Business Enterprise for Minorities, Women, and Persons with Disabilities Act (BEP Act) in their FY23 Annual BEP Expenditure Reports.

CEI continues to support, promote, and encourage the economic development of minorities, women, and persons with disabilities participating in State procurement as insurance, investment management, information technology, accounting, architectural and engineering, and legal services prime vendors and subcontractors through its Business Enterprise Program (BEP).

Insurance Services

When a State agency or public institution of higher education, excluding community colleges, awards a contract for insurance services, it must aim to utilize insurance brokers owned by minorities, women, and persons with disabilities, as defined by the BEP Act, for a minimum of 20% of the total annual premiums or fees. Specifically, contracts representing at least 11% of annual premiums or fees must be awarded to minority-owned businesses. Contracts representing at least 7% of annual premiums or fees must be awarded to women-owned businesses. Contracts representing at least 2% of the total annual premiums or fees must be awarded to businesses owned by persons with disabilities.

Investment Services

When a State agency or public institution of higher education, excluding community colleges, awards a contract for investment services, it must aim to use emerging investment managers owned by minorities, women, and persons with disabilities, as defined by the BEP Act, for a minimum of 20% of the total annual premiums or fees. Specifically, contracts representing at least 11% of annual premiums or fees must be awarded to minority-owned businesses. Contracts representing at least 7% of annual premiums or fees must be awarded to women-owned businesses. Contracts representing at least 2% of the total annual premiums or fees must be awarded to businesses owned by persons with disabilities. Additionally, it is also the aspirational goal for not less than 20% of the direct asset managers of the State funds to be minorities, women, and persons with disabilities.

The State's commitment to promoting diversity and inclusion within its investment management sector is clear. The State aims to foster equitable access to opportunities and ensure fair representation in fund management by setting aspirational goals for using emerging investment managers from underrepresented groups. Furthermore, the emphasis on diversifying the direct asset managers of State funds reflects a strategic approach to cultivating a more inclusive investment landscape, which can lead to broader economic empowerment and growth within marginalized communities.

Professional Services

The professional services category comprises accounting, architectural, engineering, information technology, and legal services. When a State agency or public institution of higher education, excluding

community colleges, awards contracts for certain professional services, including information technology, accounting, architectural and engineering, and legal services, the aspirational goal is to use firms owned by minorities, women, and persons with disabilities, as well as lawyers from these groups, for at least 20% of the total dollar amount of State contracts.

This aspirational goal underscores the State's commitment to promoting diversity and inclusion across various professional service sectors. The State aims to foster equitable access to opportunities and ensure fair representation in the procurement process by setting aspirational goals for using businesses and lawyers from underrepresented groups. Additionally, these goals encourage agencies and public institutions of higher education to actively seek out and engage with diverse vendors and legal professionals, thereby contributing to a more inclusive and representative marketplace.

Community Colleges

When a community college awards contracts for insurance, investment, information technology, accounting, architectural and engineering, and legal services, there is an aspirational goal for the community college to use businesses owned by minorities, women, and persons with disabilities for at least 20% of the total contract spending for these services collectively. However, for investment services contracts, investment managers who are not considered emerging investment managers are not counted towards these diversity goals.

By setting aspirational goals and defining specific percentages for the utilization of businesses owned by underrepresented groups, community colleges are able to promote diversity and inclusion within their procurement practices. Additionally, excluding investment managers who do not meet the criteria for emerging investment managers underscores the importance of ensuring that diversity goals are applied appropriately across different types of contracts and service providers.
