

Fiscal Year 2024 Business Enterprise Program Annual Expenditure Report BEP Achievement Executive Summary

The Commission on Equity and Inclusion (CEI) submits this Fiscal Year 2024 (FY24) Business Enterprise Program (BEP) Annual Expenditure Report on behalf of the Business Enterprise Council for Minorities, Women, and Persons with Disabilities (BEP Council) to Governor Pritzker and the General Assembly. This report outlines the qualified State of Illinois (State) dollars spent subject to the BEP aspirational goal, provides a review of CEI's FY24 programmatic accomplishments, illustrates the performance of the State agencies and public institutions of higher education subject to the Business Enterprise for Minorities, Women, and Persons with Disabilities Act (BEP Act) during FY24, and includes an analysis of the number of BEP-certified vendors.

The data in this report was submitted to CEI by the purchasing entities subject to the BEP Act in their FY24 Annual BEP Expenditure Reports and FY24 BEP Compliance Plans.

BEP continues to support, promote, and encourage the economic development of minorities, women, and persons with disabilities participating in State procurement as prime vendors and subcontractors. Through engagement and collaboration with other partnering organizations and stakeholders, BEP expands its impact by increasing participation in State contracting opportunities.

BEP Expenditure Achievement Highlights

After achieving a record 5,415 certifications during FY23, the BEP program concluded FY24 with 5,049 certified vendors. While BEP saw improvements in the full BEP certification numbers, the overall reduction in certifications can mainly be linked to a decline in vendors certified through the Be Enrolled Business Enterprise Recognition Certification (BE BEP). The partnering organizations of BE BEP that faced the most significant drop in vendor certification include the City of Chicago, Cook County, Chicago Transit Authority, PACE, and METRA. Together, certifications from these five partnering entities represent 33% of the total BEP-certified vendor pool.

Black BEP-certified vendors experienced the highest year-over-year attrition, losing 70 male-owned certified vendors and 144 female-owned certified vendors. Collectively, this decrease of 214 Black vendors accounts for 58% of all vendor attrition during fiscal year 2024. As a demographic group, Black vendors comprise 38% of the certified vendor pool.

For the third consecutive year, there has been growth in the dollars subject to BEP goals (DSG). In FY24, \$33.3 billion was subject to BEP goals, representing an improvement of \$9.7 billion from the previous year's DSG amount of \$23.5 billion. Since CEI's establishment, the DSG has grown by \$19.2 billion, accounting for a 136% increase since 2022. These increases in the DSG can be attributed to enhanced compliance reporting from agencies and public institutions of higher education and a refinement of reporting guidelines.

The State has set an aspirational goal to spend at least 30% of its total dollars with BEP-certified firms. BEP achievement reports the total dollar amount spent by agencies, boards, commissions, public universities, and community colleges on goods and services provided by BEP-certified vendors. In the past, BEP achievement was compared against the total DSG. While this approach provided the percentage of BEP achievement based on all of the DSG, it did not include data detailing achievement against the 30% aspirational goal. Starting this year, the BEP Annual Expenditure Report will provide the total BEP achievement against the 30% aspirational goal. The total BEP achievement reached during FY24 was \$1,306,647,883.

Several factors contributed to the decrease in goal achievement, such as substantial growth in DSG, requests for

purchasing entity class exemptions, changes in procurement spending patterns, variations in contracting opportunities, and shifting market dynamics. Despite the decrease in achievement percentage, the year-over-year BEP spend has increased yearly since 2017. CEI's ongoing efforts to enhance supplier diversity and strategic outreach and capacity-building initiatives have laid a strong foundation for future progress. It is also worth noting that the FY24 BEP goal achievement still signifies a substantial investment in BEP-certified vendors and sheltered workshops, totaling over \$1.3 billion. This represents a modest 1% increase over the previous fiscal year.

During FY24, 1,696 BEP-certified vendors received State contracts, compared to 1,538 in FY23, representing a 10% increase in the number of certified vendors awarded contracts. Similarly, the total number of State contracts with BEP goals also rose by 10%, increasing from 6,086 in FY23 to 6,667 in FY24. This rise in contracts with BEP goals is largely due to better adherence to BEP guidelines and greater participation from agencies, boards, commissions, public universities, and community colleges.

CEI's Operational Accomplishments

In recent years, the BEP has undergone remarkable transformations to enhance its commitment to supplier diversity and equity in state procurement processes. FY24 marked a significant expansion, with the program improving its organizational structure by adding key positions and bringing in new hires. This expansion is crucial to ensuring that BEP continues to offer robust support and opportunities to vendor partners. Additionally, CEI led several initiatives, including the launch of a new supplier diversity management system, the relocation of facilities, and the introduction of various innovative projects. These efforts reflect CEI's ongoing dedication to promoting a diverse, equitable, and inclusive business environment throughout Illinois.

New CEI Hires

The BEP structure and its organizational placement have significantly transformed over the past fiscal year. In FY24, the BEP experienced an expansion of its staff and external stakeholder offerings. CEI added more staff to the compliance unit, the Mentor Protégé Program (MPP) welcomed a new MPP Manager, and the outreach unit gained momentum by hiring its new dedicated manager. Finally, CEI onboarded a Deputy Director to lead the BEP certification unit and the Mentor Protégé Program. These positions are crucial for the BEP to achieve its mission of ensuring supplier diversity and promoting equity in the State procurement process.

Supplier Diversity Management Portal (SDMP)

Through a competitive bidding process, Viva USA, Inc., a BEP-certified vendor, was awarded the contract to host CEI's supplier diversity management platform, <u>SDMP</u>. This system change enhances the CEI's supplier diversity management platform by streamlining processes, improving user experience, and increasing data accuracy. On July 15, 2024, the SDMP was made available for public use. Purchasing entities can now search the portal for BEP-certified firms (for goal setting and utilization plan responsiveness purposes) and the contracts executed with supplier diversity goals. New certification application, renewal, and revision submissions were restarted on that date. Office Location Updates

During FY24, CEI successfully undertook several facility relocation projects. Early in the year, CEI moved its headquarters from the 4th floor to the 14th floor of the James R. Thompson Center, a temporary measure while

Central Management Services prepared the building for new ownership. Less than a year later, CEI made another significant move to the newly acquired 115 S. LaSalle building in Chicago's financial district. Shortly after settling into the new Chicago location, CEI expanded its presence by opening a second office at 524 S. 2nd Street in Springfield, Illinois. This new branch enhances CEI's ability to conduct business, facilitate public meetings, engage with stakeholders, and build relationships within the greater Springfield area. Establishing these locations marks a pivotal milestone in CEI's ongoing evolution.

Additional Support Initiatives

CEI also launched several initiatives to improve communication, boost vendor engagement, and create educational campaigns that position vendors for success.

In 2024, the BEP program kicked off a project to convert BEP documents into automated fillable forms or fully digitize them where applicable by incorporating them into the new SDMP. Additionally, the BEP certification checklist for new applicants, those recertifying, and parties eligible for our fast track and recognition programs has been updated to include only the steps necessary for certification.

In collaboration with the chief procurement offices, CEI introduced a BEP certification educational webinar series. These webinars provided practical insights into the benefits of State certification, contract bid opportunities, and other procurement resources. CEI certification analysts provided step-by-step guidance for completing the application process, and attendees received additional resources and business development information.

CEI's BEP Unit Updates

CEI's BEP Certification Unit

The BEP certification unit remains committed to fostering economic inclusion and expanding opportunities for minority-owned, women-owned, and persons with disabilities-owned businesses within the State. Throughout FY24, the BEP Certification Unit prioritized accessibility, efficiency, and transparency in the certification process while implementing key operational improvements and adapting to significant structural changes.

In March 2024, the certification unit launched monthly virtual educational webinars to guide business owners through the BEP certification process and provide post-certification guidance to newly certified vendors. Additionally, a flyer titled "Next Steps for Maximizing Your BEP Certification" was developed and is now distributed with all certification approvals, equipping vendors with clear instructions on leveraging their certification. The unit also facilitated 35 virtual office hour sessions, offering real-time support to applicants and certified vendors. Lastly, staff participated in 29 outreach events, strengthening relationships with business communities and enhancing program visibility. The BEP certification unit conducted more than 107 site visits, reinforcing compliance efforts and ensuring the authenticity of vendor operations.

Monthly internal unit meetings were established to improve communication, collaboration, and operational efficiency among certification staff. These meetings offered a structured environment for sharing best practices, discussing policy updates, and tackling procedural challenges. The unit also comprehensively updated its standard operating procedures to accurately reflect current practices and decision-making processes. This update has enhanced transparency, consistency, and efficiency in processing applications. A staff expansion initiative was approved in FY24 to increase workload efficiency and better support the growing demands of the certification unit. This expansion will enhance application processing times and vendor engagement moving forward.

The focus on transparency, responsiveness, and customer service has resulted in noticeable improvements in vendor relations. Enhanced processes have led to quicker response times for inquiries and more streamlined communication between vendors and certification staff. Furthermore, ongoing education efforts have empowered vendors with a clearer understanding of how to navigate State procurement opportunities effectively.

A significant milestone in FY24 was the decommissioning of the legacy supplier diversity certification and management system in preparation for the transition to the new SDMP. This shift represents a major technological and procedural upgrade aimed at providing a more efficient, user-friendly, and integrated experience for vendors and purchasing entities seeking certification and managing supplier diversity compliance. The transition necessitated carefully planned FY24 closeout preparations. The new system will greatly streamline certification workflows and enhance data integrity in future reporting periods.

The certification unit has developed an updated National Institute of Governmental Purchasing (NIGP) code crosswalk. Vendors use the crosswalk document to translate between NIGP commodity codes and another classification system, the North American Industry Classification System (NAICS) codes. This tool enables users to easily compare and match product categories across different platforms. The crosswalk table shows the NIGP code alongside the corresponding code from the other system, allowing users to look up a specific product category in one system and find its equivalent in the other. This crosswalk is an essential resource in ensuring that vendors request certification for all commodity codes where they can perform a commercially useful function.

FY24 was a year of strategic growth, operational refinement, and system modernization for the BEP certification unit. Key initiatives, such as enhanced vendor education, procedural updates, staffing expansion, and system transition efforts, position the unit for greater efficiency, increased vendor engagement, and a stronger impact on supplier diversity within Illinois. Looking ahead, the certification unit remains committed to expanding certification access, enhancing customer service, and leveraging new technological advancements to support the success of BEP-certified firms.

CEI's BEP Compliance Unit

CEI's BEP compliance unit ensures adherence to supplier diversity contracting requirements in the State's procurement process. The BEP compliance unit oversees goal-setting for contracts, reviews individual contract exemption requests, makes determinations about vendor good faith effort waiver requests, evaluates Utilization Plans (U-Plans), monitors the utilization of BEP-certified primes and subcontractors, and provides necessary reporting and assistance to all agencies, boards, commissions, and public institutions of higher education.

With the implementation of CEI's new SDMP, the BEP compliance unit has made significant strides in promoting equitable and inclusive procurement practices across state agencies, boards, commissions, and public institutions of higher education. The new portal will simplify various aspects of supplier diversity contracting, including contract monitoring and compliance reviews prior to award. Additionally, it will feature a BEP compliance dashboard for data visualization and reporting, along with statistical tracking that will establish a live feedback loop, offering insights into progress toward BEP goals for each solicitation and the fulfillment of collective purchasing entity objectives, which is an invaluable resource for CEI as a whole. The BEP compliance unit will also introduce an updated goal-setting methodology, a standardized U-Plan template, a good faith effort form, and individual and class exemption request forms to align with current best practices and enhance efficiency. Furthermore, the compliance unit aims to fill all vacancies within the unit, thereby increasing its overall capacity.

In FY24, the BEP compliance unit received 108 compliance plan submissions, highlighting a growing commitment from agencies, boards, commissions, and public institutions of higher education to meet the aspirational supplier

diversity goal outlined in the BEP Act. Additionally, 256 U-Plan responsiveness reviews were conducted, with 151 U-Plans meeting the responsiveness criteria, showcasing the dedication of purchasing entities to comply with BEP requirements. The compliance unit conducted 715 goal-setting form reviews in FY24. These reviews promote adherence to goal setting and foster accountability in achieving supplier diversity objectives. Moreover, the BEP compliance unit received 108 annual reports, providing valuable insights into the progress of contracts with BEP prime and subcontractor goal achievement.

As part of its oversight role in FY24, the BEP compliance unit actively monitored the contract goal commitments of purchasing entities, ensuring transparency and adherence to diversity commitments. The team provided vendors with responsive assistance, guidance, and clarity regarding BEP compliance matters. The BEP compliance unit consistently generated reports to maintain data accuracy and current insights, enabling informed decision-making and progress evaluations. Additionally, the BEP compliance unit attended pre-bid conferences as needed, addressing concerns and challenges confronted by BEP vendors and purchasing entities.

CEI's Mentor Protégé Program (MPP)

The MPP fosters the development and mentoring of minority, women, and persons with disabilities-owned businesses. It enables experienced firms to provide various types of support to create more equitable access for economic growth while meeting the State's BEP contracting goals. The MPP aims to motivate and encourage established businesses to provide developmental assistance to BEP-certified firms, to maximize access to the State's procurement programs, to foster long-term relationships, to enhance the core capabilities of minority-owned, women-owned, and persons with disabilities-owned businesses, and to increase contracting opportunities for those businesses.

CEI achieved several strategic actions in FY24 to advance the MPP and strengthen its impact. First, CEI prioritized ensuring the program is adequately resourced and supported by hiring a manager. CEI also developed a structured approach to optimize the mentor-protégé matching process, taking into account the unique needs and aspirations of protégé businesses. This personalized matching process will foster productive relationships with experienced mentors who can offer valuable guidance and support. CEI will establish a feedback mechanism to continuously improve the program's effectiveness and gather insights from mentors and protégés. Additionally, CEI will conduct regular evaluations to assess the success of mentor-protégé relationships and identify areas for improvement, ensuring the program remains responsive and impactful.

By implementing these strategic steps, the MPP will support the growth and sustainability of BEP-certified businesses, fostering partnerships that benefit both parties and promote economic empowerment. The program will also establish a dynamic network of subcontractors and prime vendors, enhancing long-term competitiveness and equitable access to the State's procurement opportunities.

CEI's Outreach Unit

CEI's outreach unit promotes the BEP by actively engaging with various businesses. Through focused outreach initiatives, the team boosts certifications and delivers outstanding customer service, ensuring businesses have the resources they need to thrive. By utilizing strong networking connections, CEI continues to broaden its outreach efforts through in-person and virtual training on the BEP certification processes.

CEI's outreach unit significantly expanded its efforts in FY24, increasing participation from 71 outreach initiatives in FY23 to 121 in FY24. CEI's dedicated team fosters awareness and participation in BEP through targeted outreach initiatives and promotion to the business community through the new SDMP, LinkedIn,

purchasing entity partnerships, external communications and collaborations, local community groups and associations, chambers of commerce, and legislative outreach.

At the end of FY24, CEI's outreach accomplishments included launching and expanding educational certification training workshops, creating a new BEP brochure, boosting outreach to diverse business owners, and providing valuable information on the benefits and process of becoming certified vendors. The outreach unit has also leveraged social media and stakeholder relationships to promote CEI's programming, offer free certification virtual office hours, and enhance accessibility and engagement. The unit remains dedicated to strengthening connections and supporting diverse business communities.

The CEI outreach unit is committed to enhancing its outreach efforts and fostering meaningful engagement with external stakeholders. To achieve this, CEI will prioritize filling staff vacancies to ensure optimal capacity for executing outreach initiatives effectively. CEI will build on this to create targeted outreach programs that connect, inform, and increase engagement with diverse businesses, promoting supplier diversity and inclusion.

In alignment with CEI's commitment to continuous improvement, CEI will launch a dedicated supplier diversity training course to empower purchasing entities conducting procurements and vendors seeking procurement and contract opportunities. This training course will equip these purchasing entities and businesses with valuable insights and resources to thrive in procurement. Additionally, CEI will collect, update, and distribute supplier diversity metrics and key performance indicators to track progress and inform data-driven decision-making. These metrics will focus on increasing supplier diversity and fostering economic development among diverse businesses. These next steps will fortify CEI's role in advancing supplier diversity and positively impacting the State's procurement practices.

BEP Council and Sheltered Market Updates

BEP Council

The BEP Council was developed to help implement, monitor, and enforce the goals of the BEP Act.

The BEP Council's adaptability to change and unwavering dedication has propelled the mission of the Business Enterprise Program forward. In FY24, the BEP Council passed the Goal Waiver Determination Resolution. This resolution fully rescinded the August 2013 goal waiver determination delegation to the Capital Development Board and public institutions of higher education. It also granted BEP the good faith effort waiver request determination responsibility. Another crucial responsibility of the BEP Council includes reviewing compliance plans submitted by State agencies, boards, commissions, and public institutions of higher education and certification appeals submitted by vendors, ensuring a holistic approach to promoting diversity and equity in State procurement practices.

During FY24, several existing reports became standing agenda items during full BEP Council meetings. The 20/20 Report transitioned from being presented only during BEP Council Compliance Subcommittee meetings to a recurring agenda item discussed in each bi-monthly BEP Council meeting. This report identifies all non-construction solicitations by state agencies exceeding \$20,000,000, with less than a 20% established goal before publication. The BEP Council also witnessed the reemergence of subcommittee reports during each meeting in FY24. Presented by each subcommittee chairperson, these reports provide a concise summary of in-depth research, analysis, and recommendations for each subcommittee, allowing the BEP Council to make informed decisions based on detailed information.

Another key component implemented into full BEP Council meetings in FY24 is the sheltered market discussion segment. This segment allows members to discuss the status of supplier diversity achievement and potential deficiencies resolved by sheltered markets. During this segment, the BEP Council receives, reviews, and discusses the progress of using BEP firms and any evidence regarding past or present racial, ethnic, or gender-based discrimination that directly impacted an agency, board, commission, or public institution of higher education contracting with such firms.

Other notable BEP Council accomplishments included implementing CEI's updated annual BEP expenditure exemption request reporting template, completing the FY24 class exemption request reviews, and promptly collecting the FY25 class exemption requests.

The BEP Council's bylaws will be revised to address FY24 quorum challenges. The BEP Council will also explore options to develop and implement a centralized contract information management system, as mandated by the BEP Act. This initiative will streamline processes and ensure better accessibility to essential contract details. The Outreach Subcommittee has been tasked with leading this responsibility. Furthermore, the BEP Council will continue assessing potential sheltered market categories and identifying opportunities to promote growth and inclusivity for qualified businesses.

Sheltered Markets

Sheltered Markets are a procurement procedure in which certain State contracts are selected and specifically set aside for businesses owned and controlled by minorities, women, and persons with disabilities through competitive solicitations. Sheltered markets are established by the BEP Council when a pattern of racial, gender, or disability-based discrimination is found in a particular industry. When establishing a new sheltered market or adjusting an existing one, the BEP Council identifies the necessary evidence. The two sheltered markets currently available are IT/telecom and advertising. The sheltered market for advertising is only for certified African-American-owned and Hispanic-owned business enterprises.

While the BEP Council didn't establish any sheltered markets in FY24, CEI did attempt a solicitation for a research partner to conduct a comprehensive and legally defensible study of the IT/telecom and advertisement sheltered markets. The Department of Innovation and Technology holds an award for the Technology Operations Professional Services (TOPS) procurement under the IT/telecom sheltered market.
