- CEI Leadership was also present at the CMS Interagency Executive Roundtable.
- CEI administration continues to meet with an assist legislative affairs and governance team in the evaluation of proposed and current legislation, so they have a full understanding of its impact on operations and programming.
- Updates to the CEI Website
 - The 2025 CEI Commission meeting schedule has been posted to the website. The upcoming dates can be found by selecting the public meeting tab.
- · Statutorily mandated reports
 - CEI received the FY24 SDVOSB and VOSB reports from each of the states four CPO's. VBP staff will utilizing this data to draft a comprehensive summary for the annual SDVOSB &VOSP report due March 1, 2025.
 - Compliance unit continues to collect outstanding 2024 Business Enterprise Program Annual Expenditure and Service Category reporting templates from Agencies, Community Colleges and Public Institutions of Higher Education. This information is the essential for determining BEP Achievement for the year.
- C. Financial and Human Capital Report Tracey Kenney, Chief Finance and Human Capital Officer
 - Staffing:
 - CEI will be conducting interviews for an additional Certification Analyst
 November 13 through 15. There are 8 candidates.
 - CEI is working with CMS to post for an additional Compliance Analyst as soon as practical.
 - CEI operational personnel are taking two customer service modules available from the State's repository of OneNet coursework as professional continuing education. CEI's continuing goal is for our personnel to operate with excellence as we serve our stakeholders.
 - Finance:
 - FY2026 budget planning has begun! CEI's fiscal department has submitted our preliminary budget to GOMB and is awaiting the ISL documents from the General Assembly to complete in timing for Governor Pritzker's budget address in mid-February 2025.
