CEI's vision is to be a trailblazing leader in fostering a diverse, equitable, and inclusive procurement environment where supplier diversity, equity, and inclusion are celebrated, and opportunities are accessible to all, driving positive social impact and economic growth.

CEI is dedicated to advancing community progress and fulfilling its statutory responsibilities while fostering collaboration with internal and external stakeholders. This includes engagement with the four chief procurement officers, state purchasing officers, agencies, boards, commissions, and public institutions of higher education to align strategies and initiatives with the broader statewide supplier diversity goals. CEI's external stakeholders include certified vendors, non-certified businesses across the State eligible for Business Enterprise Program (BEP) and Veterans Business Program (VBP) certification, industry organizations, prime vendors, and legislators. Executive Summary

Pursuant to Section 20-60(c) of the Illinois Procurement Code (30 ILCS 500/20-60(c)), the Commission on Equity and Inclusion ("CEI") is required to file an annual report with the General Assembly by August 1 of each year. This report identifies, for Fiscal Year 2025, (i) the proposed contract extensions and renewals filed with CEI by the State's chief procurement officers, and (ii) whether any such extensions or renewals were objected to by CEI prior to execution.

The reporting obligation under Section 20-60(c) applies to any contract extension or renewal for which the associated cost exceeds \$249,999. Under Section 20-60(c), a chief procurement officer is required to file notice of a proposed extension or renewal with CEI prior to entering into such action. CEI retains authority to object to any proposed extension or renewal within 14 calendar days of filing and, where an objection is raised, to require a hearing before the Commission prior to execution.

The conditions set forth in Section 20-60 do not apply universally. Contracts procured under Article 40 of the Code, emergency procurements, and procurements otherwise exempted pursuant to Section 1-10(b) are not subject to the filing and review requirements described herein. Additionally, pursuant to Section 20-60, contracts paid for in whole or in part with federal-aid funds, grants, or loans are exempt from the requirements of this subsection where compliance would result in the loss of those federal funds; in such cases, the applicable chief procurement officer is required to file notice of the exemption with CEI prior to entering into the proposed extension or renewal.

The data presented in this report were compiled from submissions made directly to CEI by the four Chief Procurement Officers of the State of Illinois:

- Chief Procurement Officer for General Services
- Chief Procurement Officer for Higher Education
- Chief Procurement Officer for the Department of Transportation
- Chief Procurement Officer for the Capital Development Board

Each CPO was responsible for gathering and submitting data from their respective records in accordance with CEI's reporting requirements. This methodology ensures that the information contained herein reflects primary-source documentation from the offices responsible for each procurement action and facilitates direct accountability and legislative oversight consistent with the General Assembly's intent in enacting Section 20-60. The analysis that follows is based on the waiver and exemption data provided to CEI.
